What is the risk to the consumer?



Food allergens may be present in a product due to intentional inclusion, part of its recipe, or due to unintentional cross-contamination.

Cross contamination can occur at any point in the supply chain or in the factory due to manufacturing process or shared equipment.

Even under conditions of Good Manufacturing Practice cross-contamination may still be difficult to eliminate entirely, therefore manufacturers are **required by law to use precautionary allergen labelling** to advise allergic consumers of potential risk.
